Discussion on application to allow/disallow the installation of signs in the Isabella County Right-of-Way on River Road, from Rolland road 3 miles west to the County Line. It was determined that the Road Commission would not be in favor of this at this time due to some safety factors.

The Finance Director reviewed the bi-weekly financial report for the period ending October 10, 2017. The Finance Director updated the Commissioners on the changes on the AR – Open Aging Summary Report. The Road Commission received the June Interest of \$287.68 and \$41.81 in Investment interest. The Finance Director informed the Commissioners the MTF funds to date increase for the new year is 21.67% (Increase of \$908,232). The Finance Director informed the Commissioners on the following things:

- 1. The State Infrastructor Loan has been approved.
- 2. The Isabella County Road Commission Auditors will be arriving on August 29th and 30th for preliminary audit review.
- 3. The Workers Comp auditor will be here on August 31st for the Workers Comp audit.

The Superintendent gave the following report:

- All gravel roads have been gone over
- All blacktop edge drops have been checked
- All potholes have been checked
- 2nd round of mowing is complete
- 3rd round of chloride is set up for next week

The Manager updated informed the Commissioners that the Lincoln Road Bridge was now open. The Manager reminded the Commissioners that the Superintendents meeting is October 4th through the 6th and Mickie would need to know if anyone was planning on attending these meetings. He also reminded the Commissioners that the East Central Meeting was next week. The Manager informed the Commissioners that he gave the Union President a letter informing them that it was time to start Union Negotiations again. The Union has selected Mike Danielski, Chris Wyman, and Scott Smith to be the Union Representatives in the negotiations.
